Objectives and Need for the Assistance

With the issuance of the NAIS strategic plan issued in April 2005 it is obvious - the goal of 48-hour trace back of any animal in the US can only be implemented by having all premises uniformly identified. This will allow all states and agencies to manage emergency data to perform the necessary trace backs. The Illinois Department of Agriculture (IDOA) through the assistance of initial USDA NAIS cooperative agreements is registering premises throughout the state and doing a massive educational program to producers and commodity groups state wide on the necessity of premises ID and how it will fit in the overall animal ID plan. The State of Illinois has been experiencing major budgetary challenges and at present, the Illinois Department of Agriculture is under considerable fiscal constraints that includes a shortage of personnel. The reduction makes it imperative to work with other cooperators to enhance the remainder of the Department of Agriculture's budget.

Results or Benefits Expected

As producers are better educated on the benefits of the premises ID registration, and the subsequent animal ID and tracking programs, Illinois will move forward with the goal of obtaining full participation in the Premises Registration System. Without all premises nationally registered the goal of 48-hour trace back will fail. The continuation of this project will insure IL continues to make adequate progress to meet the timelines laid out for NAIS progression. The stakeholders in IL will be better protected from potential disease spread through the rapid detection and response to an economically devastating disease. The livestock industry, in the event of an animal disease outbreak, will be able to more quickly return to normal animal movements and trade.

Approach

The Livestock Premises Registration will continue to be a cooperative effort. APHIS will furnish and support the SPRS and offer guidance in outreach efforts. Federal field staff will provide limited outreach to their regulated facilities. IDOA will provide staff for premises registration, implementing various outreach programs and public information, working with industry groups and overall coordination of the program. IDOA will be utilizing existing staff and equipment as well as contractual assistance from other entities, particularly industry groups.

Outline a Plan of Action

Illinois does not have a mandatory requirement for premise ID, so to obtain the maximum number of premises registered it is necessary for IDOA staff to continue to attend as many producer, commodity and stakeholder meetings as possible to provide necessary information and to register participants on the site. IDOA, the stakeholder partners, and extension service will attend and provide NAIS information at meetings identified during the previous cooperative agreement and new meetings as identified. In addition, an increased effort is going to be made on equine owners during this time frame. State and County Fairs will also be heavily targeted this year. Using the NASS lists, IDOA equine owner lists, IDOA exhibition lists, and various industry lists, new mailings will be sent out to target stakeholders. Informational radio

commercials we also be used to target counties with large livestock populations and low premises ID numbers. IDOA and Illinois Department of Public Health (IDPH) field staff will continue to acquare GPS information and solicit sign-up on sites during routine visits. IDPH regulates dairie and dairy farms. Information gathered for the GPS mapping of agriculture resources in the State of Illinois will be included in this project, downloading all registered premises into IDOA's GIS system, to further enhance sign-up.

Detail work to be accomplished.

Premises Identification

- a) The Standard system will be used.
- b) Approximately 5,400 Premises have been registered, which is about 17% of estimated premises. IDOA's goal is to obtain 25% by February, 2007 and 50% by January, 2008
- c) Stakeholders may register on line, at meetings or mail in applications which will be entered for them by IDOA staff.
- d) IDOA does not plan to enroll existing data bases into the premises ID system.

Communication Plan

1. Explain how this project supports the outreach efforts of USDA, APHIS.

The State of Illinois is working diligently to increase the number of livestock premises registered. This is the first step in the development of a National Animal Identification System.

As opposed to enforcing a federal or state mandated program – the Department of Agriculture is taking a voluntary approach and will continue outreach efforts during the next year specifically focusing on Premises Registration and its importance and value in the protection of the health of the livestock industry.

Explain how the industry will gain a better understanding of NAIS.

Attending meetings and interacting directly with producers and industry has been the best method to gaining compliance. In addition, direct mail has also been valuable. By forming the NAIS coordinating Council, information will be spread through Council representatives to their respective organizations.

In order to get a better "buy in" by producers there is a need to do more outreach to commodity/agriculture organizations and other service sector businesses, which is a goal of the Coordinating Council.

IDOA will focus outreach efforts on those businesses with the hope that it will increase the number of producers voluntarily participating in the program.

The IDOA also intends to focus more efforts on NAIS' value to Homeland Security. A master list of livestock industry information, which can be quickly accessed, will enhance the emergency response capabilities that state and federal officials can provide to producers in emergency situations. There is also a need to focus more on the potential damages that can happen from a disease outbreak that would be lessened if the agency already had animal ID information since it would reduce the time to identify animals and/or conduct trace backs in disease situations.

3. Explain how the communication efforts will be coordinated in the state/region.

The IDOA will be the primary point of contact. IDOA intends to utilize field inspectors in other divisions of the Department of Agriculture as well as other state agencies to help discuss the importance of participation in the program. IDOA depends on the Cooperative Extension Service, producer groups and other stakeholder partners to help provide information to producers. In addition, IDOA is educating state licensees about the program to encourage them to register their premises as well.

A mass mailing is being planned, using the NASS mailing list. This mailing will be supported by a large radio campaign running at the same time. The brochure to be used in this mailing is titled, "Setting the record Straight", and contains a postage paid pre-addressed registration form. The brochure is intended to respond to the variety of misinformation that has been spread about NAIS over the last year.

Last year the IDOA staff traveled to producer meetings and worked at events held throughout the state to encourage producers to sign up their premises. We plan to do the same this year as well as add more industry partners to expand this effort.

Explain how this project will work with key producer contacts to disseminate information (i.e., livestock markets, feed stores, and veterinarians).

There are a number of service industry professionals that have more day-to-day contact with livestock producers. Future success will be dependent on service professionals helping to encourage producers to participate in this program. IDOA has been asking agriculture organizations and other service industry businesses for suggestions on how to promote the program. This is another role that the coordinating Council plays. IDOA is also enhancing outreach to private veterinarians, in order to gain their support of NAIS, in hopes that they can influence their clients to support the program.

The Department of Agriculture is also utilizing the state's county USDA-Farm Service Agency (FSA) offices. FSA is allowing IDOA to put informational materials in their offices to reach producers.

Since this program is not mandatory it is essential IDOA focus on direct contact with producers. Attendance at producer meetings throughout the state has been very helpful and will continue to result in more premises registrations. Booths at various trade shows have also been beneficial and we plan to continue that and enhance with small incentives for on the spot registration. This next year, we are making additional effort to build new industry partners and enhance old ones in order to leverage our outreach.

Direct contact with producers also better allows IDOA staff to address any potential concerns producers may have in participating in this program.

IDOA also intends to use "point of service" displays, that contain information and brochures (with registration forms), in markets, feed stores, Farm bureau offices, extension offices, FSA offices, etc.

5. Explain how you will obtain feedback from stakeholders and share this feedback with USDA, APHIS.

The Department of Agriculture has worked with the University of Illinois Extension Service to develop a survey that would gauge producer participation, potential challenges; reasons producers are not participating and suggestions for future outreach efforts. This survey went out at the end of November, 2006. Survey results will be shared with USDA-APHIS. Feedback is also gained through regular contact with members of the coordinating committee.

The most important thing IDOA has learned in the last year is that face-to-face contact is essential for the overall success of this program. We also realize that we need industry partners to assist much more in this outreach effort. It is anticipated survey results may further substantiate that claim. With the development of our

NAIS Coordinating Council, we are leveraging our outreach with the same key messages.

Describe how each activity is to be accomplished:

The project manager will coordinate activities by providing brochures and staff for speaking at any requested seminar, meeting, competitions, and sales. Posters and "point of service" are used in areas where stakeholders may congregate (county fairs, sale barns, auction markets, feed stores, etc). A labeling device has been purchased so that labels appropriate for Illinois are placed on all brochures. IDOA provides printed information for events attended by IDOA staff, extension or stakeholder partners. The following brochures and handouts are extensively used: Premises forms (tailored to our state), NAIS Myths and Facts, Biosecurity Basics, and Premises ID and Animal ID/Setting the Record Straight. The "Recommended Livestock Premises Definition" sheet, USDA program aids 1797 and 1800 are being distributed. We also plan to use the new species specific brochures that were introduced in Kansas City. A new trade show booth display is being purchased to use at various events to further promote Premises registration. Power Point Presentations, fact sheets, key messages and brochures from the USDA/NAIS updated outreach messages will be distributed to our stakeholder partners so that all outreach partners are saying the same thing.

Describe any unusual features of the project.

This project is unique in that it will complement two or three on-going state initiatives. The NAIS proposal also encourages the Illinois Department of Agriculture to increase its cooperative efforts with other state and national governmental agencies. IDOA staff regularly work with staff from the Illinois Department of Public Health, the Illinois Terrorism Task Force, the US Department of Homeland Security, USDA-APHIS, VS and the Centers for Disease Control. However, this project provides an opportunity for cooperation among the aforementioned agencies to increase. This project encourages the sharing of data for purposes of homeland security. IDOA recently establish a Memorandum of Understanding (MOU) with the Illinois Department of Public Health. This MOU would allow IDOA to access valuable information on the state's dairy farms based on GPS data collected by IDPH dairy inspectors. IDOA is evaluating the potential to enter into similar agreements with other state and federal agencies in the upcoming year.

Another project receiving a large amount of attention is a GIS Initiative. In 2004, the IDOA also began work on the development of a major tool to aid with the agency's emergency response capabilities. IDOA is working to create a computer-based GIS system for all livestock facilities and agricultural assets in the state. All premises registered under the SPRS are downloaded into this GIS system.

The NAIS cooperative agreement complements both projects mentioned above and is yet one more example of interagency cooperation both among state and federal agencies.

Illinois is also unique in that it has three US Ports of Entry and two quarantine facilities. All of these facilities have registered. This is crucial as it is a key to quickly identifying locations of animals involved in commerce. It is extremely beneficial to the state and US homeland security/emergency response teams that all five of these facilities are registered. 100% compliance is very important to homeland security and a fact that the agency highlights with producers during face-to-face meetings.

- 7) IDOA FSAP Field staff-(2 Field Veterinarians and 10 Animal Health and Welfare Investigators that assist 3% each)
- 8) Other support personnel (Legal, Print Shop staff, PIO, Director and Director's Executive staff, etc.) throughout the Department of Agriculture assist from time to time 25% full time equivalent
- 9) IDOA IT staff will be assisting with this project in downloading all Illinois SPRS data as well as assisting with other data acquisition and manipulation issues. The also provide a variety of support to the Premises program, such as providing the mechanism to send letters and printed Premises ID cards to those who have registered 5%
- 10) As IDOA is not allowed to contract employees directly, IDOA has contracted with industry associations to provide obtain additional assistance with outreach programs.
- 11) Since the cooperative agreement is limited on time and funding, all staff time and benefits not reimbursed are utilized for matching costs and resources.

The results will also be used to revise educational materials if necessary to address specific areas of concern to producers regarding the program. Results of this survey should be done by January, 2007.

Legislation Implemented

The Illinois Department of Agriculture has been waiting for national legislation to be developed which would provide for specific program details and policies.

Since there has not yet been any federal legislation; Illinois intends to explore the potential for introducing state legislation requiring Premises Registration during the spring 2007 Legislative Session. Illinois is also looking at requiring Premises Registration for some state regulated or funded activities such as exhibition and animal diagnostic laboratory testing services.

• Illinois Agriculture Statistics suggests approximately 30,000 livestock farms in Illinois. This does not include equine and exotic animals that could more than double that number. Vet clinics and other such operations have not been included in the number of premises Illinois could potentially register. The goal of 25% or roughly 7500 is just an estimated guess, based on the current number. It will be difficult to improve on the current pace without making the program mandatory; however, we are hopeful that mass mailing and radio campaign will give us a substantial jump. Our goal for January 2008 is 40% or roughly 12,000 premises.

1st Ouarter Agenda:

Illinois Beef Association was contracted to help with outreach and promotion of the program. We paid the Illinois Pork producers to sponsor the Expo brochure with Premise ID information. A mailing of 31,198 was mailed regarding Premise ID to submit back Premise ID registration on materials sent out. We paid the Illinois Soybean Association for a sponsor fee to promote Premise ID. We paid the Grain and Feed Association for booth rental at the annual convention in St. Louis, Mo. Jim Kunkle made several trips to promote animal ID to various meeting groups in Carrollton, Shelbyville, Mount Vernon, Lincoln, Peoria, Bourbonnais, and St. Charles/St. Louis, MO. Paid Illinois Milk Producers for Premise ID work in St. Louis, MO., Shelbyville, Elizabeth, Effingham, and purchased 16 GPS units.

AH staff spent 95 hours this quarter working on calls, mailings, and inputting information into the Premise ID database. Dr. O'Keefe spoke at several meetings. Jim Kunkle and Mark Ernst spent time working on and promoting Premise ID.

2nd Quarter Agenda:

Dr. Ernst and Jim Kunkle attended the Business continuity and Disaster recovery meeting. We purchased envelopes for premise id mailings and banners. The Illinois Milk Producers attended meetings and were reimbursed printing and postage for a mailing. We purchased inkjet cartridges to print premise id brochures. Jim Kunkle traveled to Rock Falls, Urbana, Red Bud, Shelbyville, Mt. Vernon, Kankakee, Peoria, Lincoln, and Sterling to promote premise id. Jim Kunkle travel costs for the NIAA meeting in Louisville, Kentucky. AH staff spent 599.50 hours this quarter working on calls, mailings, and inputting information into the Premise ID database. Had premise id booths at trade shows for Illinois Beef Expo, Illinois Swine Expo, Illinois Grain and Feed annual meeting, and the Illinois farm bureau leadership conference. Presentations were made at beef round tables, swine meetings and S. W. Illinois agribusiness roundtable and extension meetings.

3rd Quarter Agenda

Jim Kunkle attended the Animal ID meeting in San Antonio, Texas. We purchased 5,000 laser sheets and paid for postage for premise id mailings. The Illinois Beef Association attended meetings and made presentations and were reimbursed for mailings. The Illinois Beef Association was reimbursed for communication pieces for advertising the premise id program. The Illinois Pork Producers were reimbursed for booth space, internet hookup at exhibit, printing inserts, and postage. We had brochures printed at Capitol Blueprint. Jim Kunkle attended the ISVMA annual conference where we had exhibit space regarding the premise id program. We purchased folding tables to display information at meetings. The IDOA had a press release regarding the program. The Illinois Milk Producers were reimbursed for attending premise id meetings. The IDOA contracted with the University of Illinois to conduct outreach programs for premise id. AH staff spent 368.50 hours this quarter working on calls, mailings, and inputting information into the Premise ID database. The Division Manager spent 10% of her time working

on Premise ID. The State Veterinarian spent 10 % of his time working on Premise ID. The Project Manager spent 40% of his time working on Premise ID.

4th Quarter Agenda:

We paid Capitol Blueprint to print 20,000 colored brochures to mail and pass out at events. A registration fee was paid for Jim Kunkle, Premise ID Manager to attend the NIAA meeting. The Illinois Beef Association conducted registration at the Illinois State Fair. Jim Kunkle attended promotional meetings for Animal ID in Annawan, Berry, and Kansas City, Missouri. The Illinois Pork Producers paid for radio advertising through the Illinois Farm Bureau. We paid for the Illinois Pork Producers to have a booth at the 2007 Illinois Pork Exp. The Illinois Beef Association paid for advertising, sent out post cards, mileage to attend meetings, travel expenses, and materials for meetings. We renewed the business reply permit for Animal ID mailings. We paid the remainder of the contract with the University of Illinois to conduct outreach and education for Premise ID. AH staff spent 157 hours this quarter working on calls, mailings, and inputting information into the Premise ID database. The Division Manager spent 10 % of her time working on Premise ID. The activities and outcomes of the effort so far are described below.

Specific outcomes of the outreach and education effort include:

- Presentations at a minimum of 30 livestock meetings to describe the Premises Registration plan and solicit producer participation. In 2004-05, over 30 meetings were held (Appendix 1) and in 2005-2006 over 40 meetings were visited across all major livestock species (Appendix 2; 2,861 individual contacts).
- Designed and distributed Premises Registration/Animal Identification slide sets to UIE Animal Systems Team members to support their outreach activities. Provided training and updates to AST members.
- Produced an internet based informational site describing the Premises Registration plan and linkage to the IDOA site (http://www.traill.uiuc.edu/).
- Designed and distributed posters to livestock markets and county fairs that describe the Premise Registration plan. Posters were distributed to all Illinois county fairs in the spring of 2005.
- To have 40% of premises registered through this agreement by January 2008.

In addition to the meetings listed, IDOA plans to make considerable additional outreach to the equine industry, by contracting leader in the equine industry to push Premises Registration to the varied equine sectors in the next few months. IDOA is also making extra efforts to push the program during the county and state livestock exhibition season this year. New brochures are being printed and will be circulated through a variety meetings, mailings and trade show and conferences. IDOA plans to continue to work cooperatively with commodity and farm organizations in order to leverage all of our outreach efforts, such as in the next four proposals.

- 1. The Illinois Milk Producers' Association and the Illinois Farm Bureau® will work jointly to accumulate addresses of known dairy producer throughout the state. A joint letter will be drafted from the presidents of the respective organizations, encouraging the dairy owner to register their premise. A letter stating their mutual support for the NAIS, the reasons the NAIS is imperative for protecting the health of our dairy cattle populations, and a registration brochure will be mailed to this accumulated mailing list. The mailing list will be accumulated from IDPH licensed dairy farms in the State of Illinois. The IDPH indicates this number to by 1,117 farms. All estimates for this proposal are based on this number.
- 2. The Horsemen's Council of Illinois and the Illinois Farm Bureau® will work jointly to accumulate addresses of known equine owners throughout the state. A joint letter will be drafted from the presidents of the respective organizations, encouraging the equine owner to register their premise. A letter stating their mutual support for the NAIS, the reasons the NAIS is imperative for protecting the health of our equine populations, and a registration brochure will be mailed to this accumulated mailing list. The mailing list will be accumulated from IDOA Coggins tests. An address list will be provided by the IDOA, upon approval of a Freedom of Information Act request. The goal of this proposal is to come up with at least 30,000 valid addresses that will be targeted for this mailing.

3. Extension proposal

Presentations at a minimum of 30 livestock meetings to describe the Premises Registration plan and solicit producer participation. In the initial phase over 40 meetings were visited across all major livestock species. Premises information and brochures will be given out at weigh-ins and check-ins for county and state livestock exhibitions. Presentations will be made and information given out at Certified livestock manager training workshops, dairy days, beef days, swine workshops and at other various livestock meetings.

Internet based informational site describing the Premise Registration plan and linkage to the IDOA site. This will continue to be supported in the next period by IL-TRAILL, which continues to have heavy traffic of livestock related visitors (i.e. over 200 hits each day). Designed and distributed posters to livestock markets and county fairs that describe the Premise Registration plan. Posters were distributed to all Illinois county fairs in the spring of 2005; this activity will continue and be expanded to livestock markets around the state.

4. Swine Proposal

Objective: To provide educational material through mailers, flyers, handouts, newspapers, inserts, magazines, radio, Public Service Announcements, seminars/presentations, and informational booths to inform the targeted audience

Targets:

County Directors- Will be informed and briefed on how they can assist with informational meetings and get information to their county associations.

Vet Clinics- Provide educational material to vets for the reason that all producers work with vets and if they are informed they might be able to better inform producers.

Co-ops - How they can assist with the campaign and to possibly provide educational material to their producer customers? Possible assistance with outreach to county associations.

County Fairs-Attend surrounding county fairs that can be feasibly visited to provide presentation and to potentially register premises'. Thomas will be attending various county fairs throughout the state judging swine shows where he plans to incorporate a presentation during or after the show.

Illinois State Fair- during the Jr. and Open shows we plan to set up an informational booth and during registration of animals there will be a booth where exhibitors will be able to register.

Allied industry-How they will be able to help with the campaign educating our targeted audience? Providing possible assistance to county associations and district directors to increase registrations.
