BACKGROUND

- 5. The livestock premises registration program was created by 2003 Wis. Act 229. This program is intended to protect animal health and the security of the food chain. Among other things, premises registration facilitates more effective disease control and a rapid response to animal disease emergencies, thus helping limit the financial impact on the livestock industry.
- 6. Under the premises registration rule, a person who keeps livestock in this state must register with the Department of Agriculture, Trade and Consumer Protection. DATCP assigns a unique premises registration number, generated by the United States Department of Agriculture, to each registered premises. Registration information is confidential, and there is no fee to register. Premise registration must be renewed every three years.

CIRCUMSTANCES

On June 12, 2008, Duane Brandner and Melissa Cochran interviewed Pat Monchilovich at his farm at 2531 County Road E, Cumberland, WI 54829. Pat Monchilovich was offered assistance with completing the application for livestock premises registration. The failure to register a livestock premises may result in fines and further legal action was explained to Pat Monchilovich. Pat refused to proceed with the premises registration application. A warning letter for failure to register the livestock premises at 2531 County Road E, Cumberland, WI was hand delivered to Pat Monchilovich. A review of the Wisconsin Department of Agriculture, Trade and Consumer Protection records, as of November 20, 2008, showed Pat and or Melissa Monchilovich had not registered their premises.

COMPLAINT SEEKING CIVIL FORFEITURE
